If the customs inspectors find more than the allowed quantities, customs will charge taxes over the difference. 			To avoid delays at customs inspection in Ecuador, each carton, box, suitcase or drawer must be packed and identified individually for each core family member. Where the operation allows, it is recommended that these items are weighted individually after packing. If possible, load the items that contain clothing, shoes and personal accessories as near as possible to the container door, as this may prevent that all goods be unloaded for inspection at customs.
