<b>Prohibited items for importation</b>	<ul style="list-style-type: none"> <li>• Weapons of all kinds (<b>including knives, daggers even if souvenirs</b>)</li> <li>• Pornography</li> <li>• Food items</li> <li>• Narcotics</li> <li>• Toxic material</li> <li>• Radioactive material</li> </ul> <p>IMPORT OF WINE AND SPIRITS: The allowance limit for import of wine and spirits for personal consumption is one litre per head.</p>
