Household Goods	The following documents are required for the importation of household goods and personal effects for immigrants or residents returning after two years:  Immigrant's declaration. Inventory of the goods. Residence permit (Dire) and work permit. Passport copy including page showing visa for Mozambique. Letter from employer or organization confirming employment contract or termination. Bill of lading or airway bill. For returning residents who have been working/studying proof of termination of employment / completion of studies is required.  The following documents are required for returning residents after an absence of less than two years: Immigrant's declaration. Inventory with values in USD. Invoice/receipts of goods being imported since the goods will be paying duty. Bill of lading or airway bill.  The following documents are required for estates from the deceased (goods forwarded to beneficiaries in Mozambique):	All immigrants are required to be physically present at the customs clearance.  No imported goods may be sold, leased or otherwise disposed of for 24 months from their date of entry, unless customs duties are paid.  Duties are required to be paid on office equipment, computers, cash registers and telex and telefax machines. Duty is assessed according to the value of the item.  For diplomatic shipments, a diplomatic card or letter of identity from the embassy or organization is required. All documents, duly completed and signed by the diplomat must be submitted to the Ministry of Foreign Affairs and then Customs for final clearance.  Diplomatic shipments must be imported within six months after the time of the diplomat's arrival.	All personal effects and household goods must be imported within two months after the returning resident's time of arrival.  All personal effects and household goods must be imported within three months after the date of the work or resident permit has been granted to an immigrant.

Other Useful Information		<ul> <li>Customs clearance for household goods normally takes 3 working days.</li> <li>Motor vehicle customs clearances takes from 2 to 4 weeks because client has to obtain a duty exemption.</li> <li>Vehicles have to be brought in within 30 days of being issued with residence permit.</li> <li>Commercial or any other cargo clearances take from 3 to 5 working days.</li> <li>NB: Telex releases not allowed in Mozambique.</li> </ul>	Citrus fruits, seeds, and deciduous plants may not be imported unless an import licence has been obtained in advance from the competent agricultural authorities.  Persons visiting, or returning residents may import alcoholic beverages into Mozambique. Those who are 18 years or older may import up to a maximum of 5 litres of alcoholic drink, of which not more than 2 litres may be spirits.  Firearms may be imported with a special permit from the Secretary of Home Affairs.  For precious metal jewellery, customs duty may be required to be deposited.  For new furniture and household goods, freight charges apply, and invoices are required.  For inheritances, no duties are payable provided the following documents are presented:  Copy of the will Death certificate Letter from the executor For wedding trousseaux, freight charges apply and invoices are
